ARTICLES OF INCORPORATION OF DEBORAH V. IRICK, P.A.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract and legally authorized to practice the profession of brokering the purchase and sale of real estate or real property interests in the State of Florida, hereby proceeds to form a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of this Corporation is DEBORAH V. IRICK, P.A.

ARTICLE II. PURPOSE AND NATURE OF BUSINESS

The purpose of the Corporation and the nature of its business are as follows:

- 1. To engage in the practice of brokering the purchase and sale of real estate as a professional service corporation and to provide services incident thereto.
- 2. To own property, enter into contracts, and to carry on any activity necessary or incidental to the accomplishment or furtherance of the purpose of this Corporation.

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is 100 shares having a par value of \$1 per share. Such shares shall be of a single class of common stock. None of the shares of the Corporation may be issued to anyone other than an individual who is duly licensed and in good standing to practice the business of brokering the purchase and sale of real estate in the State of Florida.

ARTICLE IV. DURATION

The Corporation shall have a perpetual existence.

ARTICLE V. ADDRESS AND AGENT
