I, **COURTNEY E. CHAMBERS**, do hereby subscribe and acknowledge the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

EFFECTIVE DATE



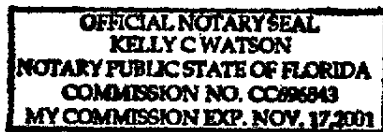
