CERTIFICATE OF INCORPORATION

OF

CONSTRUCTION CLEANING AND RESTORATION SERVICES INC.

The undersigned incorporator to these articles of incorporation hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation is Construction Cleaning And Restoration Services, Inc.
