OIVINION SEE, FLORIDAS The undersigned incorporators hereby form a corporation under Chapter 607 of the laws of the State of Florida.

> ARTICLE I. NAME

The name of the corporation shall be BLAST OFF, INC.

ARTICLE II. ADDRESS

The address of the principal office and mailing address of this corporation shall be 909 W. Amelia Street, Orlando, FL 32805.

#### ARTICLE III. NATURE AND DURATION OF CORPORATE BUSINESS

The corporation may engage or transact in any or all lawful activity or business permitted under the laws of the United States and the State of Florida or any other state, country, territory or nation.

### ARTICLE IV. CAPITAL STOCK
