ARTICLE I  
Name

The name of the corporation is Sunbeam Holding Corp.

ARTICLE II  
Duration

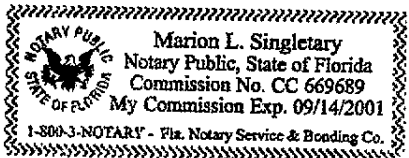
