

# ARTICLES OF INCORPORATION

OF

## CREW CLEANER, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

### ARTICLE I CORPORATE NAME

The name of the corporation shall be Crew Cleaner, Inc. and the corporations principal address shall be 777 SW 9 Terrace, Pompano Beach, Fl. 33069.

### ARTICLE II TERMS OF EXISTENCE

This corporation shall have perpetual existence.

### ARTICLE III NATURE OF BUSINESS AND POWERS

The purposes for which the corporation is organized are to engage in the business of international trading, import, export, sales of goods, purchase of goods, and the general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the United States of America and the State of Florida.

### ARTICLE IV CAPITAL STOCK

The corporation shall have the authority to issue 100 shares, all of one class of capital stock, with a par value of \$1.00 per share.

AMENDMENT

ARTICLE IX  
PRE-EMPTIVE RIGHTS



The pre-emptive right of any holder is determined by the ratio of the authorized shares of common stock held by the holder to all shares of common stock currently authorized.


