The Corporation was authorized for dissolution effective the 30<sup>th</sup> day of August, 2000 in accordance with Section 607.0704, *Florida Statutes*.


**ARTICLE III**


**ARTICLE IV**

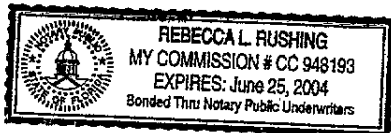




