ARTICLES OF INCORPORATION

OF

SUNIL GUPTA, M. D., P. A.

The undersigned Incorporator files these Articles of Incorporation in order to form a corporation under the Florida General Corporation Act.

ARTICLE I CORPORATE NAME

The name of this corporation shall be SUNIL GUPTA, M. D., P. A., the principal place of business shall be 51 Yacht Club Drive, Ft. Walton Beach, Florida 32548.

ARTICLE II NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage is medical services as permitted under the laws of the State of Florida.


