ARTICLES OF INCORPORATION OF KUNTRY FLORIST, INC.

In compliance with the requirements of Chapter 607, Florida Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I Name

The name of this corporation is KUNTRY FLORIST, INC.

ARTICLE II Formation and Duration

The corporation shall be deemed formed upon the filing of these Articles with the Florida secretary of state's office. The corporation's existence shall be perpetual.

Article III Purpose

This corporation is organized for the purpose of retail sales and transacting any other lawful business.

Article IV Capital Stock

The corporation is authorized to issue 100 shares of \$1.00 par value common stock.

Article V Initial Registered Office and Agent

The street address of the initial registered office of this corporation is 9624 Chumuckla Springs Road, Jay, Florida 32565, and the name of the initial registered agent of this corporation is CARLA COOK.

Article VI Initial Board of Directors

Article VII Incorporator(s)

Article VIII Principal Office

Article IX Restrictions on Stock

Unless waived by written agreement among this corporation and its shareholders, shares held by persons receiving shares in the initial issue of stock in this corporation may not be resold to other persons unless such shares are first offered to this corporation, and, if not so purchased, then to the other shareholders, at the price and terms identical to the proposed sale to a third person. Restrictions contained in this article may be modified by a separate written agreement among the corporation and the shareholders receiving shares in the initial issuance of stock of the corporation.

Article X Amendment

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

Article XI Indemnification

The corporation shall indemnify its directors, officers, employees and agents to the fullest extent allowed by law.
