The name of this corporation is A. J. HOLDING OF BROWARD, INC.

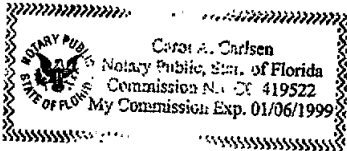
