The name of this Corporation is TARTELL AND MANDEL, M.D., P.A.

The general nature of the business to be transacted by the Corporation is:

(a) To engage in every phase and aspect of the business of rendering the same professional services to the public that a Doctor of Medicine, duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through offices, employees and agents who are duly licensed under the laws of the State of Florida to be Doctors of Medicine.

(b) To do everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objects or the furtherance of any other purposes enumerated in theses Articles of Incorporation, or any amendments thereof, necessary or incidental to the protection and benefit of the Corporation and in general, either alone or in association with other corporations, firms or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment of the purposes or the attainment of the objects or the furtherance of such purposes or objects of the Corporation.

(c) This Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be formed under Chapter 621 of the Florida Statutes.

The foregoing paragraphs shall be construed as enumerating both objects and purposes of the Corporation; and it is hereby expressly provided that the foregoing enumeration of specific purposes should not be held to limit or restrict in any manner the purposes of the Corporation otherwise permitted by law.


This Corporation is authorized to issue one thousand (1,000) shares of common stock, par value One Dollar (\$1.00) per share.
