ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Florida General Corporation Act, adopt the following articles of incorporation for such corporation.

1. The name of the corporation is ASAP Transcription Service, Inc.

3. The period of its duration is perpetual.
4. The purpose is to engage in the transcription of medical and legal documentation, as recorded by others, into other records as directed by others and any other activities or business permitted under the laws of the United States and Florida.


