## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF QUALITECH SYSTEMS OF SOUTH FLORIDA INC.



Pursuant to Section 607.1006 of the Florida Business Corporation Act, the undersigned corporation adopts these Articles of Amendment.

FIRST The name of the corporation is Qualitech Systems of South Florida, Inc.

SECOND The Articles of Incorporation of this corporation are amended by changing Article I so that, as amended, said article shall read as follows:
