OF

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. **Name.** The name of this corporation is WCH Enterprises, Inc., and the mailing address is 8209 Sandpiper Road, Fort Myers, Florida 33912 and the street address is the same.
2. **Duration.** The period of its duration is perpetual, except as the same may be dissolved as provided by law.
3. **Purpose.** The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.
4. **Capital Stock.** The corporation is authorized to issue ten thousand shares at no par value.
