ARTICLE ONE

The name of the corporation is **Jose & Maria Clavijo, Inc.** The principal address of the corporation is: 812 N.E. 17th Terrace, Apt E. Fort Lauderdale, Florida 33304.

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.
