ARTICLE I

NAME

The name of the corporation is, THE GREENERY STATION, INC., (hereinafter called the "Corporation").

ARTICLE II

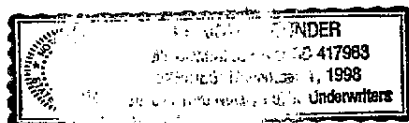
