The undersigned Subscriber, who is licensed to practice speech and language pathology in the State of Florida, desiring to form a professional corporation in accordance with the Florida Business Corporation Act and the Florida Professional Service Corporation and Limited Liability Company Act, hereby adopts and files with the Secretary of State of the State of Florida these Articles of Incorporation.

ARTICLE ONE

NAME OF CORPORATION

ARTICLE TWO

**EFFECTIVE DATE**

PRINCIPAL OFFICE OF CORPORATION

CAPITAL STOCK

The aggregate number of shares of stock that this corporation is authorized to issue is 10,000 shares, all of which shall be common shares with a par value of \$1.00.

SEVERANCE AND TERMINATION OF EMPLOYMENT

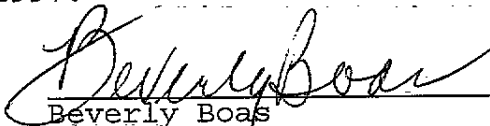
