The undersigned DEBORAH ANN HICKS, does hereby make, subscribe, acknowledge and file these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The names of this corporation shall be PROFIT CONCEPTS, INC..

ARTICLE II

NATURE OF BUSINESS

The general nature of the business to be transacted is for the purpose of trucking and storage.
