ARTICLES OF INCORPORATION

OF

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a professional service corporation under the laws of the State of Florida and pursuant to F.S. 621 the Professional Service Corporation Act

ARTICLE I - NAME

The name of the professional service corporation is RENE BERG ENTERPRISES, P.A.

ARTICLE II - NATURE OF BUSINESS

The specific nature of the business to be transacted by this professional service corporation is as:

(a) REAL ESTATE AGENT; thereby to purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with any real estate activity or business permitted under the laws of the State of Florida and the United States of America; and,

(b) To conduct business in, have one or more offices in, and buy, hold, mortgage, sell, convey, lease or otherwise dispose of real estate, in the State of Florida and in all other states and countries. To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and execute such mortgages, transfers of corporate property, or other instruments to secure the payment of corporate indebtedness as required.

which it is offered to others, which price, in the case of par value shares, may be in excess of par.


ARTICLE XIV - BUY-SELL AGREEMENT




