It has come to my attention that the Corporation filing on R.B. & Sons Harvesting, Inc. was rejected and that the Corporation was administratively dissolved as of September 24, 1999.

In calling your office to research why this has occurred, I was informed that there was a letter sent in May of 1999 stating that the FEI number was missing on the original application for renewal. This was an oversight on my part and very unintentional, however, I was not aware that there had been a letter sent regarding this matter. In August of 1999 Mr. Barajas had received a 2rd Notice form from you and gave it to me to check into. I telephoned on August 11, 1999 and was told that the application was received and cleared on May 10, 1999. This was the same time our check had cleared our account. I was not informed that there was any other problem with this filing and Mr. Barajas said he never received anything except this 2rd Notice concerning the annual report. You can imagine my surprise when our Accountant informed me that, in looking up some information on the Internet concerning something else, he ran across a notification that the Corporation had been dissolved. I'm not sure what needs to be done to rectify the situation, so I am asking for your assistance.

R.B. & Sons Harvesting, Inc. was issued FEI number 65-0800789 effective January 1, 1998. If I had noticed that I failed to put this on the annual report, I would have taken care of it immediately. I also do the filing for another corporation and the FEI number is already preprinted. This was the first renewal on R.B. & Sons Harvesting, Inc. report and I failed to notice that it wasn't preprinted on this filing. I deeply regret that this error has occurred and I would like to know what, if anything, can be done to reinstate this Corporation without costing Mr. Barajas any more time or money.

Thank you for your assistance in this matter. I will look forward to hearing from you regarding what my next step should be in taking care of the reinstatement of this Corporation.
