The undersigned, for the purpose of forming a Corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation.

**Article I - Name**

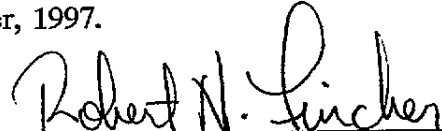

**Article VI - Corporate Existence**

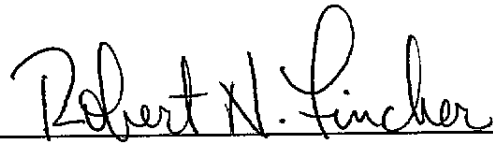
The date of commencement of corporate existence shall be 12:01 a.m., January 1, 1998, and the Corporation shall have perpetual existence.
