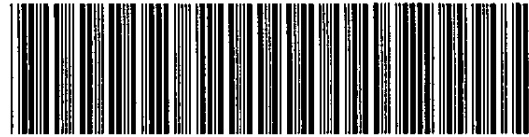



AMENDMENT TO THE ARTICLES OF INCORPORATION
OF PETER BENSEN, D.C., P.A.

Peter Bensen, D.C., P.A., a Florida professional corporation formed under the Florida Service Corporation and Limited Liability Act, hereby amends its Articles of Incorporation, pursuant to actions duly adopted by unanimous vote of the votes entitled to be cast by the Board of Directors and Shareholders on the 22nd day of July, 2012, at which a quorum of Directors and Shareholders existed and that being a sufficient number of votes cast for approval of the following amendment to the articles of incorporation, by striking the existing Article III, and replacing it with the following language:

ARTICLE III - PURPOSE

The general nature and purposes of business to be transacted, promoted and carried on by the professional service corporation are as follows:

- a. To engage in the practice of chiropractic medicine as a professional corporation and to own and operate chiropractic medical clinics for the purposes of providing chiropractic medical care and treatment.
- b. To engage in the practice of other professional healthcare services, to the extent allowed by law, including to promote scientific chiropractic medical and other healthcare research and knowledge; to furnish related laboratory and clinical services; and to own real and personal property; and to engage in any lawful business necessary for the rendering of the professional chiropractic medical and healthcare services.
- c. To do everything necessary, proper, or convenient to accomplish any of the purposes set forth in these articles, and to do every other act incidental to the corporate purposes which is not forbidden by Florida laws or by the provisions of these articles of incorporation.

The purposes of this corporation shall be carried out only through officers, employees, and agents, each of whom is licensed or otherwise legally qualified under the laws of the State of Florida to render the professional services provided.

In all other respects, the corporation ratifies and confirms its Articles of Incorporation as previously stated.

IN WITNESS WHEREOF, the undersigned has executed this Amendment to the Articles of Incorporation, effective the 22nd day of July, 2012.
