The undersigned, acting as Incorporator of the corporation pursuant to Chapter 607, Florida Statutes, adopts the following Articles of Incorporation of such corporation.

ARTICLE I

The name of this corporation shall be Accredited Licensed Mortgage Brokerage Business, Inc. The principal place of business shall be 1932 Tyler Street, Suite 207, Hollywood, Florida 33020.

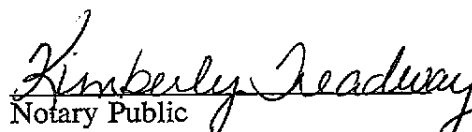

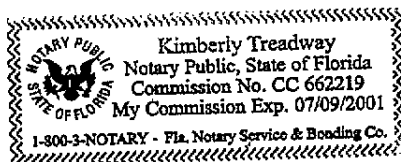
