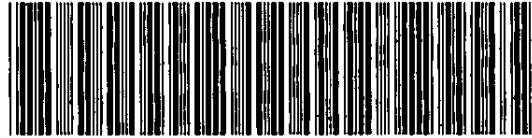

SONNEBORN RUTTER COONEY VIERGEVER BURT & LURY, P.A.


