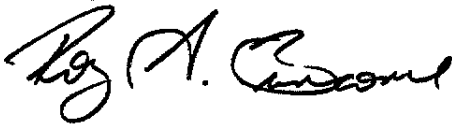

The undersigned natural person of the age of eighteen or more acting as incorporator of a corporation pursuant to Chapter 607 of the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for the corporation:

**ARTICLE ONE**

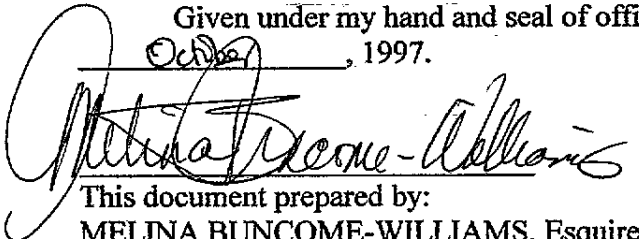

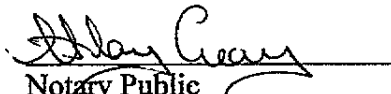

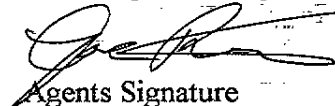
