ARTICLE I - NAME

The name of this corporation is ARABIE'S SURVEYING AND CONSTRUCTION LAYOUT, INC.

ARTICLE II - NATURE OF BUSINESS

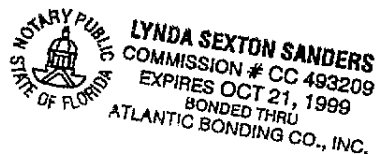
