(A Professional Service Corporation)

These Articles of Incorporation are signed and delivered by the undersigned for the purpose of forming a professional service corporation under the laws of the State of Florida. Each person signing these Articles is duly licensed or otherwise legally authorized to engage in the professional service to be furnished by this corporation.

ARTICLE I. NAME

The name of this corporation is:

ARTICLE II. EXISTENCE

This corporation shall exist perpetually.

ARTICLE III. PURPOSES

This corporation is organized for the following purposes:

- A. To engage in the practice of real estate salesperson as a professional corporation and provide services related thereto.
- B. 

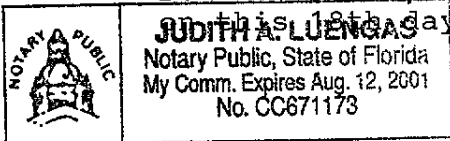


