Please find enclosed the *For Profit Corporation Uniform Business Report* for Internet America, Inc. for the years 2001, and 2002, along with two checks, each for \$150.

Earlier today, I spoke to a representative who told me to Federal Express these documents and reiterate the previous problem, which I have done below.
