97 DEC 23 AM 10:22 That the undersigned, Lynda Sexton Sanders, who is licensed to practice the profession of accounting in the State of Florida, after proper organization with intentions of forming a professional Service Incorporation Act, hereby adopts the ORIO AS corporation in accordance with the Florida Professional Service Incorporation Act, hereby adopts the Opio following Articles of Incorporation for such corporation:
