# *Articles of Incorporation* *of* The Mailbag, Inc.

## **Article I - Name**

The name of the corporation is: The Mailbag, Inc.

## **Article II - Duration**

This corporation shall exist perpetually.

## **Article III - Purpose**

This corporation may engage in or transact any or all lawful activities or businesses permitted under the laws of the United States, the State of Florida, or any other State, country, territory or nation.

## **Article IV - Capital Stock**

This corporation is authorized to issue Seven Thousand Five Hundred (7,500) shares of One Dollar (\$1.00) par value common stock which shall be designated "Common Shares".

The name and address of the person signing these Articles of Incorporation is: Ronald Shaver, at 20 S. Park Avenue, Apopka, Florida 32703.


#### **Article IX - Initial Officers**






