ARTICLES OF INCORPORATION

OF

JIMMIE BURT CONSTRUCTION COMPANY, INC.

ARTICLES I

The name of this corporation is Jimmie Burt Construction Company, Inc. of Bartow, Florida.

ARTICLES II

This corporation shall have perpetual existence, unless sooner dissolved according to law.

ARTICLE III

General Purpose and Nature of Business




