ARTICLE I

The name of the corporation is **TITAN MANAGEMENT, INC.** (the "Corporation").

ARTICLE II

The address of the principal office and the mailing address of the Corporation are P.O. Box 902248, Homestead, Florida 33090-2248.

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

ARTICLE IV

The Corporation shall hold a special meeting of shareholders only:

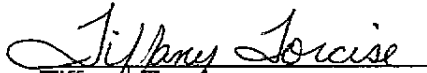
This Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by law in existence either now or hereafter.
