The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: J. L. JOST & ASSOCIATES, INC., and the address is: 4807 Peregrine Point Circle, W., Sarasota, FL 34231.

Article 2. Duration. The beginning date shall be January 1, 1998. The duration of the Corporation is perpetual.

Article 3. Purpose. The general purposes for which the Corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act. No other purpose limits this general purpose in any way.





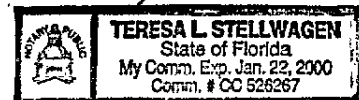
