ARTICLES OF INCORPORATION  
OF  
G & S CONCRETE, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopt the following articles of incorporation:

ARTICLE ONE  
NAME

The name of the corporation is G & S CONCRETE, INC.

ARTICLE TWO  
DURATION

This corporation shall commence existence as of JANUARY 1, 1998.

ARTICLE THREE  
PURPOSE

EFFECTIVE DATE

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE FOUR
