OF

BY THESE ARTICLES OF INCORPORATION, the incorporators form a corporation for profit under Florida law.

#### NAME

The name of this corporation is PENGUIN SERVICES OF SOUTHWEST FLORIDA, INC.

#### ADDRESS

The physical location of the corporation shall be at 2050 Ninth Street, Sarasota, FL 34237.

#### TERM

This corporation shall exist perpetually.

#### **PURPOSE**

The purpose of this corporation is to transact any or all lawful business for which corporations may be incorporated under Florida law.

# STOCK

The corporation is authorized to issue 10,000 shares of common stock with \$1.00 par value. The stockholders may dispose of the authorized and unissued stock from time to time.
