This corporation is organized for the purpose of transacting any and all lawful business.

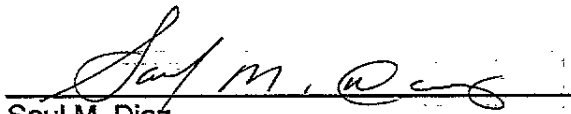
**ARTICLE IV**

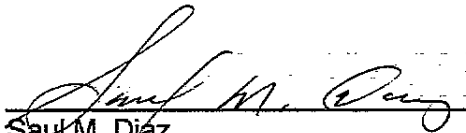
