The name of the corporation shall be BEVERLY CARPENTER INTERIORS, INC.



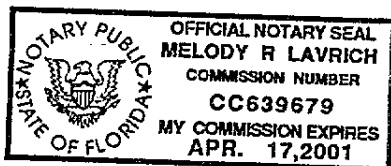
