

ARTICLES OF AMENDMENT TO THE ... ARTICLES OF INCORPORATION OF LAKE SHORE FARMS, INC.

ON AFOR THE THE

Pursuant to the provisions of Section 607.1006 of the Provida Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of this Corporation is LAKE SHORE FARMS, INC. (hereinafter called the "Corporation").
- 2. Article II of the Corporation's Articles of Incorporation is deleted and replaced by new Article II, as follows:

"ARTICLE II

The address of the principle office and the mailing address of the Corporation are P.O. Box 901309, Homestead, Florida 33090."

- 3. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.
- 4.
