

## ARTICLE ONE

The name of the corporation is SAAD FOOD STORES #1, INC. The principal address of the corporation is: 3991 N.W. 41st Street, Lauderdale Lakes, Florida 33312.

The period of its duration is perpetual.

## ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations maybe incorporated under the Florida Corporation Act.
