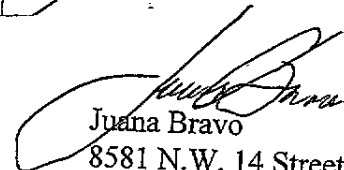

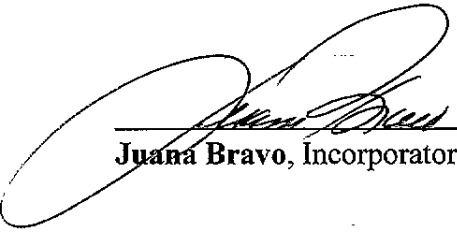
## ARTICLE EIGHT
