The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE 1

NAME AND ADDRESS

- Section 1.1 Name. The name of the corporation is Hydrochem Systems, Inc.
- Section 1.2 Address of Principal Office. The address of the principal office of the corporation is 5700 St. Augustine Road, Suite 105, Jacksonville, Florida 32207.
