ARTICLES OF INCORPORATION

OF

J.B. TAYLOR & ASSOCIATES, INC.

The undersigned subscribers to these Articles of
Incorporation, being natural persons competent to contract,
hereby form a corporation under the laws of the State of Florida.

ARTICLE I

<u>Name</u>

The name of the corporation shall be J.B. TAYLOR & ASSOCIATES, INC.

ARTICLE II

<u>Existence</u>

This corporation shall have perpetual existence.

ARTICLE III

Nature of Business

The general nature of the business to be transacted by this corporation shall be the powers inherent mentioned in Section 607.011 of the Florida Statutes, and in addition thereto, it

shall have the following powers:

- (a) To engage in any activity or business permitted under the laws of the United States and of this state, including but not limited to, agricultural management.
- (b) To the same extent as natural persons might or could do, to purchase or otherwise acquire, and to hold, own, maintain, work, develop, sell, lease, exchange, hire, convey, mortgage or otherwise dispose of and deal in, lands leaseholds, and any interest, estate and rights in real property, and any personal or mixed property, and any franchises, rights, licenses or privileges necessary, convenient or appropriate for any of the purposes herein expressed.
- (c) To purchase, hold sell and re-issue the shares of its own capital stock.
- (d) To manufacture, purchase or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer or otherwise to dispose of, and to invest in, deal in and with, goods wares, merchandise, real and personal property, and services of every class, kind and description, now or hereafter permitted by law.
- (e) To conduct business in, have one or more offices in and to buy, hold, mortgage, sell, convey, lease or otherwise to dispose of real and personal property, including franchises,

patents, copyrights, trademarks and licenses in the State of Florida and in all other states and countries.

- (f) To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes or other evidences of indebtedness, and to execute such mortgages, transfers of corporate indebtedness as required.
