

CERTIFICATE OF INCORPORATION
OF

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the said State of Florida.

Article I

The name of this Corporation shall be **Top Dawg Trucking, Inc.**

The Corporation may engage in the activity of providing trucking service and related activities as permitted under the laws of the United States and of the State of Florida.






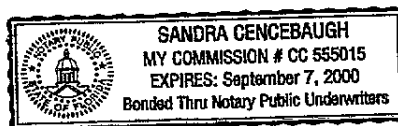
