IN COMPLIANCE with the requirements of Florida Statutes, Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the corporation is:

SALES AND SERVICE VEHICLES, INC.

**ARTICLE II**

The existence of the corporation shall begin on January 1, 1998.

**ARTICLE III**

The street address of the principal office of the corporation is: 1360 S. C. R. 427, Longwood, Florida 32750.

**ARTICLE IV**

The maximum number of shares this corporation is authorized to issue is one thousand (1,000), all of which shall be common shares. 
