The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is "MILLION MAN MARKET PAGES, INC."

ARTICLE II

The duration of this corporation is to be perpetual.
