ARTICLES OF INCORPORATION

OF

MOOREEN, INC.

STORE SE PHIOSOME THESE ARTICLES OF INCORPORATION are hereby adopted by undersigned incorporator of this corporation for pecuniary profit under the Florida General Corporation Act.

ARTICLE I NAME AND LOCATION OF AGENT AND OFFICES

Section 1.1. Name. The name of the corporation shall be Mooreen, Inc.

Section 1.2. Principal Office and Place of Business. principal office of the corporation shall be located at 2318 Bengal Court, Punta Gorda, Florida 33983. The corporation may change the location of the foregoing office, transact business at other places within or without the State of Florida, all as the Board of Directors may from time to time determine.

Section 1.3. Registered Agent and Office. The Registered Agent for the corporation to accept service of process within the State of Florida shall be the Incorporator. The street address of the Registered Agent is 2318 Bengal Court, Punta Gorda, Florida 33983.

ARTICLE II DURATION AND COMMENCEMENT

Section 2.1. Duration. The corporation shall have perpetual existence, or until dissolved according to law.

Section 2.2. Commencement of Corporate Existence. corporation's existence shall commence on January 1, 1998.

ARTICLE III PURPOSE AND POWERS

Section 3.1. Purpose. Section 5.1. Amendment. The Articles of Incorporation may be amended from time to time by resolution of the Board of Directors or by meeting of the shareholders pursuant to the procedures for amendment established under the Florida General Business Corporation Act. Section 5.2. Organization Meeting of Directors. After the corporate existence begins, an organization meeting of directors named herein shall be held at the call of the majority, to adopt Bylaws, elect officers, and transact other necessary business.

Section 5.3. Directors. The number of directors constituting the initial Board of Directors shall be one. Said number may be increased or decreased from time to time in accordance with the Bylaws of the corporation.
