## ARTICLES OF INCORPORATION

### ARTICLE I - NAME

The name of this corporation is Shawn H. Pope, P.A.

### ARTICLE II - PRINCIPAL OFFICE

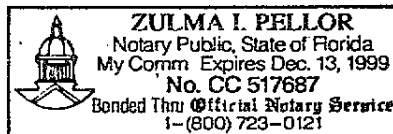
