ARTICLES OF INCORPORATION
OF
SLEEPY HOLLOW RECREATION, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the State of Florida.

ARTICLE I

*The name of the corporation shall be: SLEEPY HOLLOW RECREATION, INC..
The address of the principal office of this corporation shall be 525 N.E. 7th Terrace,
Gainesville, Florida 32601, and the mailing address of the corporation shall be the same.*

ARTICLE II

This corporation may engage or transact in any and/or all lawful activities or business permitted under the laws of the United States, or the State of Florida or any other state, country, territory or nation.
