The undersigned officer of AlterNetix, Inc. delivers these Articles of Amendment in order to amend the Articles of Incorporation of the Corporation.

ARTICLE I

The name of this Corporation is AlterNetix, Inc.

ARTICLE II

Article V of the Corporation's Articles of Incorporation is amended to read as follows:

"ARTICLE V
Capital Stock

The total number of shares of capital stock which the Corporation has the authority to issue is One Million (1,000,000) shares of Common Stock, with a \$.01 par value per share."

ARTICLE III

The joint resolution of all of the Shareholders and Directors of the Corporation changing the authorized capital stock of the Corporation was adopted on March 1, 1999.
