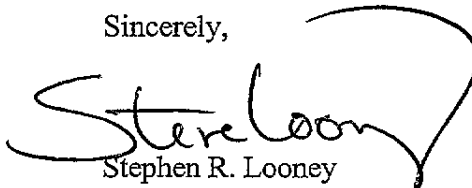

The name of this Corporation is ALTERNETIX, INC.

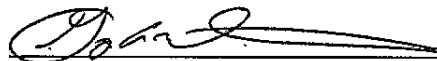
ARTICLE II
